Chilling of beer and wine will also be legal. Nearly two years after it was approved by Oklahoma voters, State Question 792 is about to go into effect and liberalize sales of beer and wine. Liquor Laws by State | Legal Beer Beer and low alcohol wine can be sold 24 hours, liquor can be sold 9 A.M. to 7 P.M. Monday - Saturday at liquor stores. 17.5% ABV cap on beer and 16% on wine. No liquor sales on election day. South Dakota - Sale is not controlled by the state.
